NOTE: Arlington County may elect up to 180 members of the County Committee, 490 delegates to the District Convention and 985 delegates to the State Convention. If fewer than the maximum number file, all will be elected automatically. If a greater number should file for any position, a party canvass open to all Republican voters will be held, on Sat., Mar. 10, 2012, 10am-2pm, at ACRC HQ, and the candidates receiving the most votes will be elected. The time and place of the canvass may be changed as warranted; updated information will be available online and by phone.
